#### LEADERSHIP

1. Why are you running for this elected office?

I'm running for Oakland City Council District 3 because I feel our city is on the wrong track. Neighbors continue to share concerns about public safety, homelessness, and pollution. We deserve a representative who responds to us and can deliver meaningful changes that help our residents, workers, and business owners. I know what it takes to make change effectively, and I'm ready to serve as the next Oakland City Council Member for District 3.

2. How would you describe your leadership style?

My leadership style is rooted in collaboration, inclusivity, and active listening. I believe that the most effective solutions come from engaging directly with the community, understanding diverse perspectives, and working together to address challenges. I prioritize open communication and transparency, ensuring that everyone has a voice in the decision-making process. By fostering a culture of collaboration, I strive to build strong, trust-based relationships that empower communities and drive meaningful change.

In addition to being collaborative, I am results-oriented and proactive. I focus on setting clear goals and taking decisive action to achieve them, while remaining adaptable to new information and feedback. I believe in leading by example, holding myself accountable, and inspiring others through a shared vision of equity, justice, and sustainability. My approach is to be a hands-on leader who is deeply connected to the community, responsive to its needs, and committed to making a tangible difference in the lives of Oakland residents.

3. If elected to office, what will be among your top legislative and budget priorities? Specify your goals.

My top 4 issues are the following:

- Affordable housing: Streamlining affordable housing development in priority equity neighborhoods to by-right approval to add more affordable housing units in Oakland and prioritize Oakland's city-owned vacant properties for affordable housing development and social services
- Economic Development: Provide provisional licenses for Oakland merchants to fill vacant storefronts in priority equity neighborhoods to improve access to jobs and resources in Oakland
- Traffic Safety: Pre-authorize traffic calming contracts so the Oakland Department of Transportation can improve traffic safety in low-income communities impacted by traffic violence more efficiently
- Transparent and Responsive Governance: Build trust and transparency within local government by improving access to department contact lists with clear documentation of work plans and decreasing response times to community inquiries.

# **VALUES**

1. As a leader in our community, whom do you consider your base?

I consider my base to be the communities of color, LGBTQ+ communities, and Oaklanders who have never felt heard by their city government. They drive our economy, enrich our cultural fabric, and contribute to the resilience and vibrancy of our neighborhoods. However, these are the residents who face the daily challenges of rising housing costs, environmental injustices, and economic inequality.

My commitment is to respond to these voices, ensuring that their needs and aspirations are at the forefront of every policy decision.

2. If elected, what are the core values that will guide your time in office?

The core values that guide my campaign and will also guide my time in office are: equity and justice, community-centered solutions, collaborative leadership, and integrity. I believe in fighting for policies that address systemic inequalities and support working families, communities of color, and the unhoused populations. My decisions will be driven by the needs of the people I represent in District 3, especially those who have historically been marginalized and seen no action taken for them.

I am committed to leading with transparency and ensuring that residents are actively involved in shaping the policies that impact their lives. I will champion environmental justice initiatives, promote green infrastructure, and support clean energy to create a healthy, livable city for all. Collaboration across diverse communities and organizations will be key to addressing Oakland's challenges, and I will work to build coalitions that create comprehensive solutions. Integrity and accountability will be the foundation of my leadership, and I will always strive to act in the best interests of Oakland's residents.

My vision for Oakland is a city where every resident feels seen, heard, and supported—a city that realizes our shared dreams of health, happiness, safety, and opportunity for all.

3. If elected, what will accountability to your constituents look like? How will you ensure on-going partnership with and accountability to your constituency?

I pride myself on being as accessible as possible to my neighbors and constituents and have modeled what that looks like during my campaign. I provide everyone I meet with my work cell number and email address and offer to take them to coffee in their neighborhood. I've learned during my career as a city planner how valuable it is to meet people where they are and listen to their stories of hope and resilience.

Alongside making myself available to individual constituents, my campaign will continue to host listening sessions based on specific subject areas lifted up by community members including transportation, housing, public safety, and economic development, among others. These listening sessions offer me and my constituents an opportunity to discuss what their priorities are and answer questions about what we can do together to meet their needs.

As councilmember, I plan to continue these practices by hosting office hours in neighborhood cafes and plazas where residents can stop by and share ideas with me. Additionally, I will establish working groups for District 3's and the city's priorities and

issues. These priority-based working groups would create concrete goals for their priority areas—from public safety to traffic safety to small business support – and develop an annual work plan to meet them.

#### **POLITICAL**

1. What is your plan to win this election?

Our winning plan is to provide real solutions through a lens of actionable policy and immediate next steps to the long-standing problems facing our district such as: a lack of support services, a need for accessible and affordable housing, clear gaps in infrastructure investment.

By ensuring these questions are answered on social media, delivered by email/phone, and discussed when knocking on doors or during neighborhood meetings, I will show Oaklanders in District 3 what a functioning, policy-forward councilmember can do for our community.

As someone who has worked within the city of Oakland, I know first hand what we need to do to make our government work for all of us—and I know how to do it.

During COVID-19, I served as section chief of Oakland's Community Resilience Program and led a cross-agency team with a tight budget, limited staff resources, and an incredibly accelerated timeline. There was no room for delay. We developed and quickly implemented a range of responsive programs, from community testing sites to outdoor merchant spaces to Slow Streets. Within City Hall, I got hard things done. What's more, I spent a lot of time thinking about how we can do things better.

I know that if our government is united around a cause, we can get things done—and quickly. By clearly identifying our primary challenges, setting bold timelines, and holding ourselves accountable and responsive to progress and to the community we serve, together we can create a government that works for all Oaklanders.

6. What is your plan to limit the influence of corporate money in elections and politics in general?

I support and plan to uphold the City of Oakland's existing campaign finance restrictions including (1) limits on individual campaign donations; (2) limits on PAC donations; (3) candidate spending limits. I also support and aim to promote Oakland's Democracy Dollars program which aims to provide residents with money they can donate to individual local elections

## **VALUES ALIGNMENT**

The following are the values and principles that inform the policies and budget priorities the members of Oakland Rising Action strive to co-govern with electeds who align with as well. Please read the following statements and respond to the highlighted question at the end.

#### COVID-19

The COVID-19 pandemic has laid bare the gaps in our social safety nets and illuminated the failings of government in caring for all residents, particularly Black and brown working-class communities. ORA supports resources/policies that prioritize to ensure our most vulnerable communities, our unhoused, immigrant, and incarcerated neighbors, are taken care of and can thrive.

#### Housing/Homelessness

ORA believes in policies that create and preserve deeply affordable housing, protect the rights and interests of tenants, particularly those who are low-income, Black, immigrants, formerly incarcerated and people of color, and end the criminalization of homelessness.

## **Economic Development**

ORA believes in community benefits agreements for large-scale private development projects. We believe that public land should be used for the public good and that giant corporations should pay their fair share. Any terms of development in our town should be on our terms. This includes projects such as the East Oakland Coliseum. We work to ensure we are creating living-wage jobs, access, and economic opportunity for Black and undocumented workers.

#### **Workers and Labor**

ORA believes that the City of Oakland should use their full authority to partner with State and Federal Labor Departments to uphold labor laws. We believe workers have the right to unionize and strike when necessary to receive fair wages and protections. We believe the City of Oakland must work closely with community partners to build a robust Department of Workplace Employment Standards Department.

#### **Public Safety**

ORA believes Oakland's approach to public safety needs to advance multiple strategies at once; including: accountability and consequences around police violence and misconduct, a major culture shift in the force that builds back community trust, re-entry support services for our formerly incarcerated community members, violence prevention and restorative justice programs for youth, and more.

# **Budget**

ORA believes that the City Budget is a (moral) compass for priorities and that our City must prioritize the needs, services, and impacts of Black and Brown communities. In that, we believe the police budget takes too much of our shared resources and we must reallocate those funds to community programs and services, in line with our values around Public Safety we believe... Additionally, revenue generation needs to include holding corporations accountable for paying their fair share.

#### **Arts and Culture**

ORA believes arts and culture are inherent to building a safe, thriving, and healthy community. We believe a larger investment in arts and culture is critical to Oakland's continued impact globally. We believe the city must prioritize the development of cultural hubs or zones throughout the city.

#### **Environmental Justice**

ORA believes in policies that implement principles of just transition and environmental justice to create healthy communities where people can thrive. Black and Brown communities are being severely impacted by annual occurrences of Climate Change related impacts, like wildfires along with regular shut-offs from investor-owned PG&E, as well as policies and programs that do not adequately address the poor air pollution from major emitters like the Port (West Oakland) and Foundry (East Oakland). We believe in creating Resilient Communities and investing in clean, renewable infrastructure that can also serve our everyday needs and intervene in Climate Crises.

#### **Fair Elections and Campaign Finance**

ORA believes that equitable democracy is critical for a healthy local government. Healthy local government requires open and ongoing communication between community members and their representatives. Black and Brown communities in the flatlands are impacted by our current campaign finance system that allows money from outside of Oakland to have an oversized influence in our local elections. We believe in transforming our campaign finance system by implementing Democracy Dollars and strengthening campaign finance policies and oversight so that Oakland residents have equitable influence in our elections and help create a healthier local government.
