I am proud to live and work in a city with strong renter protections already in place. I support Oakland's vacancy tax, tenant right to counsel, tenant anti-harassment legislation, tenant right of first refusal to purchase, just-cause eviction protections, and other similar legislation, and would support strengthening or expanding these laws, especially in the case of a repeal of Costa Hawkins. In Oakland I believe the main barrier for renters to find and maintain stable housing is the lack of supply of affordable housing in the city, in office I will focus on increasing affordability by (1) increasing the supply of housing at all affordability levels such that there are enough units that the market keeps the price low, (2) provide opportunities for renters to buy their at-risk or naturally affordable units thus removing them from the rental market altogether, (3) supporting land trusts that maintain rental units at affordable levels for low-income families.
