Transgender people who are incarcerated are particularly vulnerable to violence and isolation no matter where they are housed in California jails and prisons. Do you support policies to improve the safety and dignity of incarcerated transgender, gender-nonconforming and intersex (TGI) people, including the right to be housed consistent with their gender identity and based on their perception of health and safety?

Mounting evidence suggests that well-intentioned but misguided and unnecessary genital surgeries on babies born with variations in physical sex characteristics violate the basic medical injunction to "first, do no harm." These surgeries are irreversible and often result in extreme physical, mental, and emotional trauma. Three former U.S. Surgeons General called for an end to these surgeries absent a need to ensure physical health. Leading pediatric hospitals in the U.S. have begun to institute partial moratoriums on these surgeries. # Can you describe your strategy to raise the funds necessary to meet your campaign budget? Who do you anticipate supporting your campaign financially?

While the campaign is holding local fundraising events hosted by friends, neighbors, and colleagues—including many within the LGBTQ+ community who are passionate advocates for our shared goals in their communities. The majority of fundraising is coming from calling my personal contacts directly and asking them to support the campaign. That includes family members and lifelong friends from college, all of whom have generously supported my first-ever campaign.

As the campaign progresses, we will expand our outreach to include the broader community of Oakland's District 3. I am committed to actively engaging residents, inviting them to invest in a campaign that champions their interests and addresses their concerns.

## Please describe any experience or involvement you have had with the LGBTQ+ community. You may include steps you have taken to advance civil rights or social justice for LGBTQ+ people and/or personal relationships (family members, friends, etc.), or experiences which have helped shape your viewpoint on LGBTQ+ issues.

I identify as a gay black man and have strived to advance the rights of LGBTQ+ people my entire adult life. First, as an out and proud man, I have been recognized by several news and media publications as a leader in my field of practice, City and Regional Planning. I believe it is incredibly powerful for people like myself to showcase our intersectional identities in professional settings so that our community is represented effectively and broadly.

Second, I founded a black gay men's social network and support system called Black Queer Men's Brunch. What began as a group of five friends at my kitchen table has grown over ten years to a network of over 400 members with multiple spin-off groups. We engage in a diverse series of programming throughout the year including panel discussions, social gatherings, movie nights, book clubs, volunteer days and arts and culture-related events. Lastly, I served for several years on a gay men's health nonprofit board (and rose to be a Vice President of our San Francisco chapter). Our worked focussed on making access to PrEP easier for men in our region and to destigmatize gay sex and healthcare.

#### Please describe any legislation or public policy priorities you have or plan to work on as an elected official that will advance LGBTQ+ civil rights or social justice? As an Oakland City Councilmember I plan to focus on affordable housing and homelessness in

our City. A significant number of unsheltered individuals identify as LGBTQ+. So, this policy area is a direct overlap with serving our community.

Secondarily, my district is home to the majority of the LGBTQ-focussed and owned businesses of the City. So, I plan to prioritize business development and support systems for our small businesses to help continue to create a thriving social community for our LGBTQ residents and visitors.

Lastly, I want to focus on supporting our newly created LGBTQ district in Oakland and have already begun providing policy guidance to their leadership board to advance their efforts in placemaking and fundraising.
